Payment

Payment conditions

You will be able to pay by credit card (VISA, Mastercard, American Express and JCB) during the online registration process. All payments are to be made in Thai Baht (THB). All rates are applicable to 7% Thai VAT.

On exception, bank transfers will be accepted. If you would like to pay by bank transfer, please email ispo2027@cdmthailand.com to request an invoice. Payment by invoice will be possible until 45 days prior to the congress. Please note that an administrative charge of THB 1,000 will be added to the invoice amount.

Registration confirmation

On completion of the online registration and payment, a confirmation email containing all the details of your registration will be sent immediately. You will receive a unique QR code in a separate email from support@expopass.co. Please present it at the congress for quick and easy check-in. Approximately two weeks before the congress, registrants will be sent an email including all other logistical details and important congress information.

Cancellation and changes

Cancellation of registration

Registrations can be cancelled and will be refunded minus an administrative charge of THB 3,300, provided the cancellation is received by Monday, 25 January 2027. For cancellation received after this date no refunds will be made. All cancellations must be made in writing to ispo2027@cdmthailand.com.

Approved refunds will be processed after the conclusion of the ISPO World Congress 2027 using the original method of payment where possible.

Transfer of registration

Your registration may be transferred to another member of your organisation, subject to a THB 1,700 processing fee.

Non-attendance (No-show)

If a registered participant is unable to attend the congress for any reason, no refund or credit will be provided for non-attendance.

Double Payment / Overpayment

If you require a visa to travel to Thailand for the congress, please contact the Thai Embassy or Consulate in your country or region. The Embassy or Consulate will advise on specific visa requirements, such as information on travel visa application and submission procedures, required documents, application fees payable, etc.

The registrant is responsible to inform himself / herself in full and in a timely manner of the pertinent requirements for entering Thailand (e.g. visa requirements).

Upon completion of registration and payment, you will receive a **registration confirmation email** with a link to download your **Visa Invitation Letter**. This letter is not required for participants eligible for visa exemption or visa-free entry to Thailand; however, the system will still allow all registrants to generate and download one if needed.

Data protection

The transfer and processing of personal data between CDM Thailand and ISPO is carried out in accordance with the European Union General Data Protection Regulation (EU GDPR), the Personal Data Protection Act (PDPA) and any other applicable data protection law. Where the two laws differ, the standard giving you the greater protection is applied.
